# Learn How to Use the CLC Judging Procedures

Judges' Training Workshops are in-depth training conducted to educate CLC members in the correct application of CLC judging procedures. Those who have not judged before and would like to judge at the 2020 Grand National, as well as those who have judged before, are encouraged to attend. It is also excellent preparation for those entering a car for judging —learn what you should do before you get to the Grand National.

#### WHAT IS A JUDGES' TRAINING WORKSHOP?

It is six-plus hours of training, including classroom instruction and the actual judging of cars. **Classroom Instruction** will cover:

- Judging Foundation—Rationale, Philosophy of Judging, Judging Standard
- Entrant and Judge responsibilities

Practice Judging includes demonstration of the "as-new" judging standard. It also involves actually judging a potential show car followed by critique of the judging performed by workshop participants.

#### **JUDGES' RECOGNITION PROGRAM**

A recognition program for judges has been established to recognize those who judge. Participating in a Judge's Training Workshop will be awarded 3 or 4 points depending on each individual's performance. More details on the Judges' Recognition Program are provided on the CLC website.

Kansas City, MO 64111. The Holiday Inn has a full restaurant and bar. The rate is \$119 a night plus taxes. It includes covered parking, shuttle to the training location (when the shuttle bus is available) but does not include

breakfast or airport shuttle.

Book your room by **April 10, 2020**. Call **(816) 753-7400**. Ask for CDL—**Cadillac Training** rate. If rooms are available after that time, the \$119 rate will still apply.

the Workshop will be cancelled. In the event of cancellation of the Workshop, the fee will be refunded. Maximum limited by date of registration form receipt: fees will be refunded to those

persons exceeding 50.
